### **A Growing Crisis**

New Jersey's Childcare Funding Cuts

In July 2025, New Jersey stopped accepting new applications for its Child Care Assistance Program (CCAP), due to limited funding. Child Care In New Jersey

The state's budget failed to include an additional \$30 million needed to keep CCAP open to new families; without that, many working families now fall through the cracks.

What this means: even families who just miss subsidy eligibility may now lose access to affordable childcare, making it much harder for parents to stay in the workforce or pursue

## A Vision from Afar: New Mexico's Universal Childcare

While NJ is cutting back, New Mexico is making a bold leap forward:

Starting November 1, 2025, New Mexico will become the first U.S. state to provide no-cost, universal childcareto all families—regardless of income. <u>Governor Lujan Grisham</u>

The state will remove income eligibility requirements, waive copayments, and reimburse providers directly. <u>Universal</u>

Families are expected to save around \$12,000 per child annually on average.

- To support the system, New Mexico is also investing in:
  - A \$12.7 million low-interest loan fund to build or expand childcare facilities (with additional funding requested in future years) New Mexico Sun
  - Incentives for programs that pay entry-level staff at least \$18/hour and maintain 10-hour, 5-day schedules
  - A campaign to recruit more licensed home-based providers and increase supply, especially for infants, toddlers, and children with special needs
- New Mexico's move is attracting attention nationwide as a potential model for how states can treat childcare as a public good, not a privilege.
